

#### Education is our Future

#### A letter from the Chairman, Ted Fawcett

Since the beginning of January 2014 a great deal of hard work has been undertaken by a group of people local to Bedford who are passionately committed to offering a better life to desperately poor and orphaned children in Southern Uganda. This has been a response to the work of Father Boniface Kaayabula, a Ugandan priest, who since 1997 has been seeking to offer a future to some of the poorest children in the world. You can read more about Father Boniface's work on our website, www.evcuganda.org.

Many of the children he is involved with are orphaned, destitute, sick or abused and some are from the poorest families who cannot afford to feed them. Father Boniface has sought to provide many such children with a caring and loving environment, where education can take place and they can experience a happy childhood and have increased opportunities and hope for the future.

This Project has now become a registered UK Charity and has a Board of Trustees. A 3 year Business Plan for the Charity has been written and, at the end of 2014, we launched our website. In July 2017 two Trustees will again make the annual visit to the Project in order to oversee the work being undertaken.

There is now an official EVC Uganda Child Sponsorship Programme in place. this provides individual children with an education, accommodation, food, clothing and school equipment, all within a loving and caring environment. Individual Child Sponsorship is £240 annually. This can be paid by standing order at £20 per month or in total once per year. Currently there are over 100 children sponsored.

At present there are well over 250 children still needing sponsorship, a number which is continually increasing. Enabling children in such situations to gain an education means they are 50% more likely to survive and flourish than if they do not have this opportunity. So education is a life saver!


