**Governance and management**

The charity is operated under the rules of its CIO - Foundation constitution adopted by the trustees on 18<sup>th</sup> May 2014 and registered with the Charity Commission on 8 August 2014.

The skills and experience required by the Trustee Board is regularly reviewed and, where gaps are identified, new trustees with the requisite skills and knowledge are actively sought.

All new trustees receive a personalised induction, which includes meetings with existing trustees. They receive copies of key documents and updates on their roles and responsibilities as required.

**Objectives and activities**

The prevention or relief of poverty in Uganda by providing: grants, items and services to individuals in need and/or charities, or other organisations working to prevent or relieve poverty.

**Public benefit statement**

The Trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the Charity Commission's general guidance on public benefit, 'Charities and Public Benefit'.

**Summary of the main activities undertaken for the public benefit**

EVC's main activity is child sponsorship. This is supplemented by a church appeals programme and a number of other one-off and recurring activities to fund improvements in the infrastructure at schools which the sponsored children attend.

In setting our programme each year we have regard to both the Charity Commission's general guidance on public benefit and prevention and relief of poverty for the public benefit. The trustees always ensure that the programmes we undertake are in line with our charitable objects and aims.

### **Summary of the main achievements during the period**

#### Child Sponsorship Programme

Just under 20 new children joined this programme during the year thereby benefitting from the life changing opportunity of education.

#### Church Appeals

Due to the restrictions imposed by the COVID-19 pandemic, this year we were only able to hold 4 church appeals, nevertheless the funds generated are critical for our work. We continue to receive great support from the church communities. We are also working to diversify our funding streams in order not to be over reliant on one source of income.

#### Assistant Project Manager based in Uganda

During the year an Assistant Project Manager was recruited to help in overseeing the construction projects at St Matia Mulumba. This post is funded through a donation from EVC Uganda to the employing body in that country.

#### Projects

We are grateful to the Allan & Nesta Ferguson Charitable Trust for a donation of £7,000 towards the construction of a vocational classroom block at St Matia Mulumba.

The construction of this block together with the boys' dormitory were substantially completed during the year. The dormitory is now in operation but the vocational classroom block still needs to be fitted out.

#### Trustees

Robert Bbaale retired from the Board this year and we thank him for his contribution.

### **Financial review**

The deficit for the year was £43,291 (2019: surplus £48,482) which has been deducted from general reserves. As described below, in large part this reflects monies spent on building projects which have been accumulated during previous periods.

In addition to the funds transferred to Uganda for child sponsorship, during the year an additional £4,755 was transferred principally by way of contribution to salaries and administrative costs in Uganda, to buy a printer/scanner and to contribute towards staff training costs.

A further £64,047 was transferred to fund the construction projects at St Matia Mulumba - £35,947 for the boys' dormitory and £28,100 for the vocational classroom block. Finally, an amount of £859 was transferred as the final instalment of a solar lighting project.

In summary £138,868 was sent to Uganda in the financial year.

As of 31<sup>st</sup> December 2020, total reserves were £47,058 (2019: £90,349) which were represented by cash at bank. This includes restricted funds of £14,238.

### **The charity's policy on reserves**

EVC needs reserves in order to properly plan for unforeseen significant financial expenditure. The annual financial planning and regular monitoring/review process

enables the reserves to be maintained at the right level. The level of reserves is reviewed on an annual basis and in accordance with increases in income and expenditure. A cash flow analysis aids this process.

The board has set up a reserves policy that requires:

- Reserves be maintained at a level ensuring EVC's core activity could continue during a process of unforeseen financial difficulty;
- Takes into account planned activity levels;
- EVC's commitments.

The following headings were used in the development of the policy:

- The current reserves policy statement, as above;
- Risk assessment against each category of income and expenditure;
- Future activity levels, likely requirements and levels;
- EVC's commitments;
- Statement of the required reserves level as a result of the above.

### **Financial risks**

The trustees have examined the major strategic, financial and operational risks the charity faces and confirms that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

As EVC is staffed entirely by volunteers and has not entered in to any long-term financial commitments, the level of financial risk to which the organisation is exposed is very low. All child sponsorship and development projects in Uganda are financed entirely by monies received from sponsors and donors.

### **Plans for future periods**

EVC continues to operate very successfully with low costs and a sound financial base. The work continues to thrive and grow and we thank all our donors and supporters for their great support.

### **Chairman's report**

As I look back on 2020, with all its disruptions, I am pleased to report much positive news about our work in Uganda. The building of a boys' dormitory at one of our primary schools has been completed and has given the boys a matching facility to the one EVC built for the girls in 2018. Work has begun on the building of a five classroom block, which will be used for the teaching of IT and vocational skills and also house a library for the school. This will be completed in the near future and all of this work is a great step forward for the school. Regular inspections are carried out by qualified people on all EVC building work and the standard is consistently very high.

With the closure of schools in March 2020, due to the virus, our team in Uganda has worked tirelessly and successfully to provide outreach education to the EVC sponsored children in their homes. On 15 October, those children due to sit their Primary Leaving Examination and those secondary students due to sit GCSE and A-level exams, returned to school. We hope to see the schools re open as soon as is

possible but whilst they are closed we will continue to have in place a programme of educational outreach for the children in their homes.

The numbers of new people taking out child sponsorship for education has increased steadily during the year, but not at the levels of previous years, due to the lockdown and, our ability to promote our work, being restricted. We now have 300 plus children sponsored in education.

The generosity of our donors continues to provide the vital resources we need to ensure real hope for the future for poor Ugandan children. We cannot thank donors enough. Workaid has provided tools for use in vocational training in the larger of the primary schools we use and, additionally, we have received funding from The Allan & Nesta Ferguson Charitable Trust. We have also received funding from Wilmslow Wells for Africa. This will enable us to build the toilet block for the new classrooms and also, enable us to provide water harvesting facilities on all three new buildings in the smaller primary school we support.

This year we established the Gifts' Register on our website, to ensure that our donors are able to check that any gifts they send have reached their sponsored children. The EVC Newsletter continues to provide regular updates on our work to donors and supporters. We continue to work in partnership with St Georges RC Church community in Wembley and EVC is their 2021 Lenten charity. We seek partnership working with other relevant and ethical organisations.

A Wills / Legacy leaflet is now available and is on our website. We are using ethical social media outlets to create greater awareness about our work and to seek further funds. EVC's website is also regularly updated.

The Charity's aim is to raise the standard of education of our sponsored children so that every child has the opportunity to reach their full educational and vocational potential. The progress of every child will be closely monitored and managed to this end. This will include putting in place a fully resourced library, other key resources, regular teacher training and recruiting more well qualified teachers.

EVC is built upon cornerstones of Christianity, integrity and trust. We understand the message of light and hope Christ brings to the world and, I am proud to say that EVC Uganda is a vibrant part of that message. As donors, volunteers and Trustees we have not walked past on the other side of the road when seeing the plight of the poor children we serve. Rather we have all worked together to provide real hope for the future for those who have so little. We will continue to work tirelessly to this end during 2021 and beyond.

As the trustees of the charity you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').



The Allan & Nesta Ferguson Charitable Trust – used to construct a vocational classroom block at St Matia Mulumba school.

Vocational classroom block – used to construct a vocational classroom block at St Matia Mulumba school.

St. MM Boys Dorm – used to construct a boys dormitory at St Matia Mulumba school.

**3. Trustees' remuneration**

During this period, a total of £536 was reimbursed to 2 trustees for expenses incurred.
